General Notes about Supplies

- The FORB kits and boxes are intended to be re-filled, please do not distribute these supplies or discard used kits/boxes after use
- Any changes to the supply catalogue will be posted on towardtheheart.com
- Use older supplies first. Remember: First In, First Out (FIFO)
- Naloxone has an expiry of ~2 years. Please check inventory periodically.
- When a lot is due to expire, the BCCDC will send out an expiry communication along with information on how
 to replace the contents of your kits and boxes via email. Updates will also be posted to
 www.towardtheheart.com.

BCCDC Weekly Processing

- Please fill in all site information fields in full as well as indicating on the form any changes to contact information to avoid delays in order processing (alternatively e-mail: naloxone@bccdc.ca with the update site information form for any site updates).
- Orders are processed every Thursday for timely processing, we recommend submitting your order by Wednesday end-of-day. All orders received after the cut-off time of 11:59 pm on Wednesday will be processed the following week and delivery will be delayed.
- The supplies will be packaged at the BCCDC pharmacy. **Delivery time is expected to be 10 working days from the Thursday processing date.**
- To avoid disruption of services, plan ahead and place an order before you run out of stock.
- If you'd like to add additional kits or boxes to your site's inventory, please email the FORB initial Supply Order form to naloxone@bccdc.ca.

How Much to Order

- We suggest that sites order as and when needed to avoid a surplus of stock that may go unused or expire.
- For sites responding to a high number of drug poisonings, such as Overdose Prevention Sites, we recommend monitoring inventory closely and planning ahead to avoid shortages.
- Naloxone ampoules and loose supplies should be ordered to replace the contents of the 10 dose and 20 dose boxes
- For training we recommend ordering 1 syringe, 1 water ampoule, and 1 ampoule breaker per person
- Replacement bottles should be ordered to refill the contents of the blue 3 dose kits. For each 3 dose kit being refilled, please order: **1 replacement bottle**. Please be sure to order additional loose supplies as needed.
- The 10 and 20 dose boxes contain <u>FORB instruction cards</u>. However, this is not provided with the 3 dose kits, <u>here</u> is a print ready resource should your site require it.

BCCDC May Contact You If:

- Your order is unusually large or small
- Your site consistently orders kits or boxes rather than replacement supplies
- Your order requests fall outside the FORB program scope (e.g. requests for supplies to distribute to individuals. Please refer to the THN program information)
