- Please inform BCCDC and your health authority representative of any changes to your site or contact information.
- Please inform BCCDC and your health authority representative if you anticipate or are experiencing a substantial increase in ordering volumes. We will review your site order history/frequency of orders to help us allocate supplies to support the increased needs.

- Quantities you receive may have been adjusted to ensure equitable distribution of supplies across the province (we will notify sites of any changes to their order).
- Sites will be notified if there are any substitute products in their order.

## Placing an order

- Complete the order form and email to [harmreduction@bccdc.ca](mailto:harmreduction@bccdc.ca) (or fax to 604-707-2516). Please include your site name and ID in the subject of the email.
- The deadline for submitting orders is **end-of-day Monday (end-of-day Friday when there is a holiday Monday)**; orders received after that will be processed the following week. However, if your site is urgently low on supplies, please contact us.
- We recommend that you order in bulk every three months or more to meet our minimum order requirements. We will contact you if your order doesn't meet the requirements.
- Deliveries may take up to 10 business days from the date that orders are processed.

## Receiving an order

- When your shipment arrives, please use the order form you submitted to check that you've received the correct items in the correct quantities and notify us if you haven't. Please also confirm that the supplies have reached you in good condition. If you have any questions or concerns, please email [harmreduction@bccdc.ca](mailto:harmreduction@bccdc.ca).
- Use older supplies first. Remember: **First In, First Out (FIFO)**.
- Please check the contact information for your site on the packing slip. If any information is incorrect and needs updating, please email us to correct it.

## \*Dimensions for Vinyl Tubing

- Small Diameter: 1/4" x 3/8"
- Medium Diameter: 5/16" x 7/16"
- Large Diameter: 3/8" x 1/2"
