

The BC Centre for Disease and Control (BCCDC) Take Home Naloxone (THN) Program was developed in 2012 to provide life-saving training and naloxone kits to people at risk of experiencing or witnessing an opioid overdose.

Take Home Naloxone Kit

Each Take Home Naloxone Kit Includes:

- 3 x Naloxone, 0.4 mg/mL, 1 mL ampoule in capped and labelled amber medication bottle
- 3 x Vanish Point® 3 mL syringe
- 3 x Alcohol Prep Pad
- 1 x pair of non-latex gloves
- 1 x Individual breathing mask in pouch
- 1 x SAVE ME Steps instructional sticker
- 1 x Overdose Administration Form*
- Naloxone expiry sticker located on the outside of the kit



**The overdose administration form is included inside every THN kit. The completion of these forms provides valuable information to the BCCDC which helps to inform our program. Please encourage or support clients to complete this form if a kit has been reported as 'used'.*

Eligibility

The BCCDC THN program aims to provide low-barrier access to naloxone kits for individuals. Kits are available, at no cost, to:

- Individuals at risk of an opioid overdose
- Individuals likely to witness and respond to an overdose such as a family or friend of someone at risk

The BCCDC THN kits are **not** intended for occupational use and should not be provided when the naloxone is intended for:

- Health Care employees
 - Health care employees seeking naloxone for occupational use in the workplace. Staff should speak to their employer or regional Health Authority [Harm Reduction Coordinator](#) for procurement
- Occupational health & safety purposes
 - Both intranasal and injectable formulations and supplies can be purchased from a community pharmacy

- Use by private business or other “for profit” locations
 - The BCCDC THN kits are not currently available for private businesses, however, both intranasal and injectable formulations and supplies can be purchased from a community pharmacy

Not-for-profit community organizations that work directly with clients at risk of opioid overdose may be eligible to participate in our [Facility Overdose Response Box \(FORB\) program](#).

Training

For those wishing to obtain a kit, staff must ensure that individuals are able to demonstrate competencies relating to: overdose risk, recognition, and response.

Site Types

- **Independent** sites order and receive kits/supplies for their site only.
- **Primary Site** sites order and receive kits/supplies on behalf of their own site, as well as ‘Satellite’ sites which are typically nearby.
- **Primary Sites:**
 - Must advise how many kits were transferred to which satellite site using the [Kit Transfer Record](#)
- **Satellite** sites pick up kits from nearby Primary sites. Satellite sites do not order directly from the BCCDC.
- **Satellite sites:**
 - Must submit an application to the BCCDC using the [Satellite Site Registration Form](#)
 - Must provide Primary Sites with adequate notice to order and receive supplies on their behalf
 - Must submit their own [administration records](#) directly to the BCCDC

Ordering

Independent and Primary use the latest [THN order form](#) orders to replenish kits and supplies. Orders may be faxed to 604-707-2516 or emailed to naloxone@bccdc.ca The weekly order cut-off is 11:59 pm (end-of-

day) every Wednesday. Orders received after this time will be processed the following week on a Thursday. Please allow 10 business days for delivery and plan ahead to avoid shortages.

Wallet cards that provide information on the Good Samaritan Drug Overdose Act (GSDOA) are available for ordering in batches of 50. We recommend ordering the wallet cards to provide in THN kits when given out and they can also be provided as a loose supply. Contact Information

Please ensure the THN program is informed of changes to contact information at your site to avoid the requisition form from not being processed (e-mail: naloxone@bccdc.ca for any site updates).

Distributing and Reporting

Reporting: distribution data is an important way to evaluate the THN program. Sites will be contacted on an annual basis to complete a survey on the total number of kits given out over a two week period. Sites will receive an invitation to participate with detailed instructions on how to report.

While typically a single kit is provided to an individual, site staff may use their discretion and provide additional kits to those who may be at higher risk. Examples might include individuals who live in rural and remote areas where first response times are lengthy, or those collecting kits on behalf of others at risk.
